NECDA Projects

1. KwaZulu-Natal ECD Relief Project

In partnership with the National Education Collaboration Trust, UNICEF and seven NECDA members, NECDA successfully implemented the KZN ECD Relief Project.

The project reached 2 113 Parents/Caregivers, 1 134 ECD Practitioners, and 45 978 children from 55 ECD centres in 12 districts in KwaZulu-Natal.

We thank all the implementing RTO partners, the curriculum development partners, NECT and UNICEF for investing in and delivering an impactful and high-quality training programme that enhanced the capacity of parents and ECD practitioners.

UNICEF conducted a post evaluations assessment, and the report highlighted the sterling job undertaken by NECDA's implementing partners. Congratulations to TREE, LETCEE, ELET, New Beginnings, Lulamaphiko, Cotlands, MCC, ITEC, Motheo Training Institute and Ububele.

Participant responses

"I learnt a lot of things. Bonding with children, giving yourself time to play with them and communicate with them. We did not know that. We thought it's a teacher's job to teach children how to read and write at school. We used to shout at them when, for example, they are playing with sand because we thought the child is being naughty and making themselves dirty. The training changed our mindset".

"Since I did this training, I now know that I am not supposed to stress too much. I now tell myself positive things and I am now confident about myself."

2. QCTO Level 4 ECD Qualification

NECDA commenced the roll out of the Occupational Certificate: Early Childhood Development Practitioner, SAQA ID: 97542.

Rene King, the project lead, hosted the national Training of Master Trainers in Cape Town in October, and Master Trainers were identified in Kwazulu-Natal, Gauteng and Western Cape. Trainers were selected from TREE, LETCEE, Motheo Training Institute, Hope Worldwide, ORT SA Cape and Grassroots. Trainers

were highly competent, experienced, and fully engaged in the process. Provincial workshops were hosted in October and November in the Western Cape and KZN. Eight member organisations registered for the provincial Training of Training sessions, with 20 participants in attendance.

A NECDA Level 4 Gauteng Training of Trainers provincial workshop is planned for the first quarter of 2023. The date will be announced.

3. UNICEF Water, Sanitation and Hygiene (WASH) project

In partnership with World Vision, NECDA implemented a WASH project in the Eastern Cape and Free State. The project was funded by UNICEF.

This project aims to improve COVID intervention, hygiene and nurturing care practices in ECD Centres and surrounding areas. It was successfully implemented in Komani and Gqeberha in the Eastern Cape, and in Bloemfontein and Botshabelo in the Free State.


NECDA developed materials for the project, including a rapid assessment instrument, an ECD Practitioner's Manual, and a Faciliator's Guide. NECDA built the capacity of 12 local community-based organisations to conduct rapid assessments and train 50 ECD Centres in the two provinces.

Congratulation to ITEC for successfully leading this project in the Eastern Cape and Ntataise Trust for implementing in the Free State.

Right: NECDA developed the ECD Practitioner's Manual for the project.




4. Membership Management System (MMS)

Recognition of Prior Learning (RPL) for the QCTO qualification

Proposed subcommittees

Pre-level 4 capacity building of the entire ECD workforce sub-committee

This sub-committee will undertake a series of engagements to determine what course content should be included for practitioners that are not able to complete the Level 4 qualification, as part of resolving the professionalisation and articulation challenges.

The intention is to curate existing course content from NECDA members, and to then get the short courses endorsed. This is the start of creating alternate pathways to practice, and to ensure the capacitation of the entire ECD workforce. Alignment of the pre-level 4 courses with the PIECCE (Project for Inclusive Early Childhood Care & Education) standards and QCTO ECD Level 4 qualification will lay the foundation for further professionalisation and articulation conversations. Funding is required to support this initiative.

Recognition of Prior Learning (RPL) for the QCTO qualification subcommittee

The role of this committee is to unpack and understand the RPL landscape and determine the process and pedagogy to be followed to recognise the prior learning of ECD practitioners who meet the criteria for the QCTO qualification. Funding is required to support this initiative.

Skills audit of training providers sub-committee

This sub-committee will be responsible for conducting a skills audit of training providers to inform the ECD Sector Skills Plan produced by ETDP SETA. The research will also compile a comprehensive list of non-accredited short courses or skills development courses that ECD resource and training providers offer.

Finance sub-committee

The sustainability of NECDA is the responsibility of the finance sub-committee. This committee will determine the process for member organisations to express an interest in fulfilling the role of managing NECDA's finances. Once the member organisation has been appointed, the sub-committee will mentor and coach the organisation on NECDA's financial policy, procedures, and systems, with the view of the organisation taking over this function from ITEC in 2023.

We will be communicating more about this in the first quarter of 2023.
